#### 1307.01 REGISTRATION REQUIRED.

No general building contractor, plumbing, electrical, heating, piping, sewer building, air conditioning or refrigeration contractor, building tradesman, building repairman, tree service, paving contractors, or any other individual offering such services for a fee, shall perform any such work within the Village without first obtaining a certificate of registration from the Village Clerk and/ or her designated representative.

### 1307.02 APPLICATION; DISQUALIFICATION.

Application for a certificate of registration shall be upon the form issued by the Village Clerk and/ or her designated representative and shall be accompanied by proof of insurance coverage for such applicant and his employees for claims occasioned by personal injury and property damage. Contractor must show proof of workers compensation.

Evidence of repeated violations of this Building Code or other ordinances shall be sufficient evidence to disqualify the applicant from receiving a certificate of registration.

## 1307.03 APPEAL.

Any applicant to whom a certificate of registration has been denied or revoked by the Village Clerk and/ or her designated representative may appeal such a decision to the Village Council

#### 1307.04 DURATION AND FEE.

The certificate of registration shall be valid for the calendar year in which it is issued, and application shall be made for a renewal annually thereafter. An one time registration fee of twenty-five (\$25.00) shall be paid with the application. Effective January 1, 2023, the following registration fees shall be paid with all applications;

Individuals and organizations employing four or fewer employees	\$ 25.00
Organizations employing five or more employees	\$ 25.00

#### 1307.05 REVOCATION.

The certificate of registration may be revoked at any time by the Village Clerk and/ or her designated representative for violation of this Building Code or other ordinances, laws, rules or regulations of the Village.

## 1307.06 HOMEOWNER'S EXCEPTION.

The provisions of this chapter shall not apply to a homeowner as an individual desiring to perform work on the premises in which he resides.

That this ORDINANCE shall therefore be in full force and take effect upon its passage and the signing by the Mayor, President of Council, and Clerk.
