Out of executive session at 6:17 PM. No action taken.

The pricks are finished at the town hall it looks very good.

Mr. Detrick asked for an automatic grease gun. He uses the gun for the packer 1 time a month and he uses it more on the chassis. The cost is about \$200.00. It was approved to get a grease gun after we sell the cump truck.

Mr. Detrick asked about chip and seal with a fog Sidney St. and Pickerlltown the cost would be about \$46,000 plus a little patch work. Mrs. McKelvey asked if he can wait one more year because of the COVID-19 virus. Mr. Detrick said NO! This work can be done but it needs to come out of the County Road Tax money. It cannot exceed \$50,000.00

Mr. Detrick is having back problems again. He has had back problems since 2004 and shots usually help. But he could not get into the doctor because of COVID-19. He will get his 1st injection May 1st and maybe surgery later in the year.

Mr. Keller sent everyone an email about the flood and trees. All Council members will look at it and read for next meeting.

Chief Oelker gave his call status from January at 288 calls and went up to 703 calls for April. Mrs. McKelvey asked if this is more calls or more patrol. Chief said more patrol.

Facebook live sound was not working. Clerk turned off.

The Police building will be about six more weeks until finished. He received camera quote in the amount of \$5802.95. This will be taken out of his Capital Outlay and if they will not buy back to cameras he will donate them to Lions Park for splash pad. He also priced equipment shelving and lockers for \$4600.00 out of Capital Outlay. Chief Oelker asked if he can VTC the floor instead of seal concrete. It will be about \$1900.00. He can purchase the flooring when the cruiser and cage is sold.

Ms. Kauffman said the safety committee would like to see the building and the progress. Chief said a Saturday or after 3:00 PM would be fine.

Mrs. McKelvey and Mrs. Griffith Finance committee has looked at the budget and lost revenue from the COVID-19. The municipal tax, local tax, sales tax, gas tax, etc. we are estimating about \$106,000 loss in revenue so far this year. Rita said the municipal tax will be 6-8 months delayed. We need to find where to budge will be cut. It was discussed to cut fireworks, we laid Secretary off for now and saved some money, talked about Mosquito spraying, stet sweeping, and saving money when Dennis retires. Mrs. Griffith does not want paid for Council meetings January – May 1st. We also talked about not opening the splash pad this year. It was agreed to cancel mosquito fogging if Mr. Detrick can get out of the contract. Mr. Detrick said he would cut one street sweeping. Mrs. Griffith said she would give up money allocated for the bridge. Talked about postponing taking trees down at Lion's Park. Mr. Detrick will check trees with Jeremy and see if any tree can wait. Neil Adams hurt his back and has not been able to work much.
