Ordinance 2019—23 entitled "AN ORDINANCE TO AMEND THE ANNUAL APPROPRIATION ORDINANCE 2019-04 FOR THE VILLAGE OF WEST LIBERTY, OHIO FOR THE FISCAL YEAR ENDING DECEMBER 31, 2019." was read. A MOTION was made by Mrs. McKelvey seconded by Mr. Hyland to suspend the rule requiring three separate readings. Motion Carried. A MOTION was made by Mrs. McKelvey seconded by Mrs. Griffith to adopt Ordinance 2019-23 on first and final reading. Motion Carried.

Mrs. McKelvey would like to thank everyone who supported the Splash pad and very impressed with the committee raising \$91,000 since March.

Ordinance 2019-24 entitled "AN ORDINANCE AUTHORIZING THE MAYOR AND CLERK TO ENTER INTO A CONTRACT FOR ENGINEERING SERVICES AND DECLARING AN EMERGENCY" was read. A MOTION was made by Mrs. McKelvey seconded by Mrs. Griffith to suspend the rule requiring three separate readings. Motion Carried. A MOTION was made by Mrs. McKelvey seconded by Mrs. Griffith to adopt Ordinance 2019-24 on first and final reading. Motion Carried. Yeas: 6 Nays: 0.

Finance will meet with Terry Thompson from Republic Services to give us options for tipping fees and recycling options.

Mrs. Griffith and Mrs. McKelvey met with Jim Sawyer and agreed to bid Phase II and completion of the police building. Things will be omitted or reduced.

Mr. Hyland said he like for the Chief Oelker to look into body cameras.

Solicitor Moell is working on the land in Schools name at Dodge park. It needs to be put in the Village's name to apply for grants.

Talked about the lighting at Dodge Park and we did not commit to lighting one field yet. The cost will be about \$62371.00.

Mrs. Griffith asked if the Village can set aside funds to repair the bridge. This is a blight area of town.
