Chief Hostetler said he had Aaron Pappas fill out an application to be a fire fighter. His board approved his hire and asking Council to also approve. He has no schooling but will need 120 hr class. A MOTION was made by Mrs. Griffith seconded by Mrs. McKelvey to approve Aaron Pappas for a firefighter. Motion Carried.

Chief Hostetler has applied for several grants. Champaign County are going to MARCS radios and he submitted a grant for \$49980.00 for radios chargers, mobiles, etc. Should about this late winter/spring. He has also applied for AFG grant for fire hose for \$66,000. He find out late spring/early summer. Last grant he applied for was a new fire truck in the amount of \$380,000.00 and will find out next July/August.

Fire chief will be gone for the month of January for vacation.

United Way will have an online auction. Fire Chief said he will be auctioning off a ride to WLS school in the fire truck in March up to 4 kids. They need to live in WLS school district.

There are two open Council seats. Sam Park is interested in being on Council.

Ordinance 2019-14 entitled "AN ORDINANCE ESTABLISHING THE SALARIES AND WAGES FOR THE STREET DEPARTMENT EMPLOYEES IN THE VILLAGE OF WEST LIBERTY, OHIO AND PROVIDING FOR THE PAYMENT THEREOF" was read. A MOTION was made by Mr. M. Hostetler seconded by Mr. Keller to approve Ordinance 2019-14 on 2<sup>nd</sup> reading. Motion Carried. Yeas: 4 Nays: 1.

Ordinance 2019-15 entitled "AN ORDINANCE ESTABLISHING THE SALARIES AND WAGES FOR THE POLICE DEPARTMENT EMPLOYEES IN THE VILLAGE OF WEST LIBERTY, OHIO AND PROVIDING FOR THE PAYMENT THEREOF" was read. A MOTION was made by Ms. Yoder seconded by Mr. Keller to approve Ordinance 2019-15 on 2<sup>nd</sup> reading. Motion Carried. Yeas: 5 Nays: 0.

Ordinance 2019-16 entitled "AN ORDINANCE TO AMEND THE ANNUAL APPROPRIATION ORDINANCE 2019-04 FOR THE VILLAGE OF WEST LIBERTY, OHIO FOR THE FISCAL YEAR ENDING DECEMBER 31, 2019." was read. This ordinance is to allow PS & L Loan and Colepak to donate to Splash Pad. A MOTION was made by Mrs. McKelvey seconded by Ms. Yoder to suspend the rule requiring three separate readings. Motion Carried. A MOTION was made by Mrs. McKelvey seconded by Mrs. Griffith to adopt Ordinance 2019-16 on first and final reading. Motion Carried.

Mrs. McKelvey recommended the safety committee take over the trash/Garbage rubbish and getting a contract with Republic Services. The finance has so many other things to do and they need help. Ms. Yoder and Mr. Keller said they will help. Clerk will get with Howard Weinerman to meet with them.

Mr. Detrick could not make it today but he would like to pay Neil Adams as he goes for cutting down trees at Lions Park. Council agreed to pay as long as Clerk received an invoice.

Clerk said the medical insurance increased 13.38% the premium will be \$11,268.63 not including Nate Fickle. Clerk is getting a few more quotes.

Chief Oelker needs permission to order uniforms and vests in the amount of \$4000.00. New uniforms have not been ordered since 2017. A MOTION was made by Mrs. Griffith seconded by Mrs. McKelvey to approve the purchase of uniforms not to exceed \$4000.00. Motion Carried Yeas: 5 Nays: 0.

Mrs. Griffith wants to ask if we could set aside funds for the bridge. In order for us to get a pedestrian bridge it would cost about \$100,000-\$150,000. The residents do not want a vehicular bridge. Will look at Choice One Engineering to apply for a grant. Clerk asked Solicitor Moell to look at the school owned property and get the paperwork started to transfer over.

No update on the vac truck yet. Mrs. McKelvey wants to keep the prevention of flood on the agenda. She would like to have a Thank you banquet with light refreshments and desserts on December 10<sup>th</sup> at Green Hills Foundation Hall at 7:00 PM. All involved will be invited. A MOTION was made by Mrs. McKelvey seconded by Mrs. Griffith to allow Clerk and Secretary to get all desserts, plates, drinks, etc not to exceed \$500.00. Motion Carried. A plaque will also be presented to hang in Council room.

Council met with WL Ball Assoc. and decided to have a community meeting at Green Hill Foundation Hall to get community input on funding for lights at Dodge Park. This will be Tuesday November 19<sup>th</sup> at 7:00 PM. All are welcome. Things discussed were a low interest loan, levy for parks and recreation, or nothing. A 1. Mil would bring in about \$26,000 a year for 1.5 mil would be about \$39,000. Clerk will find out how much this would cost a property owner of \$100,000 home. DP& L gave a quote to move the transformer to a better location so lights can be installed and better location for concession stand. A MOTION was made by Mrs. McKelvey seconded by Ms. Yoder to approve D P& L to move transformer not to exceed \$5000.00 asap. Motion Carried. Yeas: 5 Nays: 0. The ball association will upgrade the breaker box and trenching.
