Our Code Enforcement Officer Scott Woodruff has been fielding many calls regarding the revised flood plain maps. I have taken a few calls and many of you are being contacted by your mortgage lender regarding your need to obtain flood insurance. Many of you have not had any flooding in the time that you owned your home. Those who have experienced flooding remember when the Mad River breached the banks in May 2019 and may have questions regarding flood insurance. So let me give you the updated information that we know at this time.

The previous flood plain map was approved/created in 1985. The current one has been debated and discussed for almost 10 years. The 2014 Flood Plain Map has not been approved at this time, BUT will be later this year.

Based on the information that we received from FEMA’s mapping contractor on 4/19/23, anticipates they will issue the Letter of Final Determination (LFD) for Logan County and Incorporated Areas on 5/30/23. These letters initiate a 6-month period before the new flood maps and study are scheduled to become effective on 11/30/23. From what we know the banks are trying to get ahead of this but are very early in the process when many of you were contacted in January 2023.

ODNR will contact all the Logan County communities with dates for webinars that will explain the regulations update process. ODNR will then schedule individual meetings with all the communities to provide one-on-one ordinance update assistance.

The Village of West Liberty will be holding a **Public Meeting on August 28th** at 6pm in Town Hall Opera House with Alicia Silverio (NFIP State Coordinator and Floodplain Management Program Manager) and Allison Fowler (Logan County Floodplain Manager) to explain what you can do as a homeowner to either refute the floodplain area for your home AND/OR how to obtain flood insurance which fits your risk.

Below is the link to the FEMA Map Service Center where you can select the state, county, and community to search for your specific property. The website is <https://msc.fema.gov/portal/advanceSearch>

After you click search you can then select from the Effective Products which are the older 1985 maps and the Preliminary Products which are the newer maps which will be approved later this year.

If you select the preliminary maps for example, there will be a drop down listing the panel numbers and you can select the download button on the right.

Once downloaded it is a little easier to scroll on and zoom in and out. You may want to use the preliminary map on one screen and the auditors site or google earth on another screen to compare the aerial views and confirm you are looking at the correct property when you are doing searches on the maps.

There is a physical map in the Village Office for you to view as well. Questions may be brought to a public meeting in August where we will invite some experts to answer your questions.

It is recommended that if any residents are able to secure a letter of map amendment from FEMA, that it be filed with the deed so that future property owners, etc. would know about the status change because FEMA would not redo a map for individual properties, and it may be years before we get a new map study.

- 1) Turn phone on and that should bring up a search bar.
- 2) Touch camera icon and point it at the QR code. The square digital bar code.
- 3) Tap on the onelink.to/feelathomewl link and it will take you right to the app site

From there you can fill out a profile to sign up for and customize alert notifications, view latest village information, see what events are coming up, look up zoning requirements, check out council minutes, etc. There is a lot going on in this user-friendly app! And it's FREE. By adding the app to you phone and customizing alert notifications you'll be able to get only alerts that pertain to you.
