

Ordinance 2022-05

AN ORDINANCE ESTABLISHING THE SALARIES AND WAGES FOR THE POLICE DEPARTMENT EMPLOYEES
IN THE VILLAGE OF WEST LIBERTY, OHIO AND PROVIDING FOR THE PAYMENT THEREOF.

BE IT ORDAINED, By the Council of the Village of West Liberty, Ohio three-fourths of all members thereto concurring:

Section 1. Salary/hourly rate for Village of West Liberty Police Department will be as follows:

Chief:

Salary: \$60,361.60 annually

The Chief of Police works 40 hour minimum work week, 80 hour minimum per pay period, payable from the General Fund every two weeks in equal installments. The duties of the Chief shall be consistent with the Ohio revised Code and the Mayor of the Village, who shall be advised by the Legislative Authority.

Patrol Supervisor:

Hourly: \$23.98 per hour

Patrol Supervisor works 40 hour minimum hour, 80 hours minimum per pay period, payable from the General Fund every two weeks in equal installments. The duties of the Patrol Officer are consistent to the Ohio Revised Code and the Police Chief and Mayor of the Village, who shall be advised by the Legislative Authority.

Officer:

Full Time:

Hourly: (Currently filled position) \$22.00 per hour
(Open position) \$21.00 per hour

Full Time is based on a 40 hour work week, 80 hours pay period paid every two weeks in equal installments from the General Fund.

30 hour position (currently open):

Hourly: \$18.00 per hour

Position is based on a 30 hour work week, 60 hours per pay period, paid every two weeks in equal installments from the General Fund.

Part-Time officers

Hourly: \$16.50 per hour.

The Chief of Police shall be responsible for turning a signed (by the Chief and officer) pay-sheet every two weeks stating name of officer and hours worked, to the Payroll Officer-Village Clerk/Treasurer.

Section 2. That this Ordinance is hereby declared to be a measure made necessary to protect the health, safety, and welfare of the Village of West Liberty, Logan County and shall be in effect March 25, 2022.
